

DISCUSSION OF OUR FUTURE OPTIONS

Fusion Leisure decided they cannot take on the pool, which is disappointing news. After the council's rejection of our proposal, this was our last good prospect of working with someone to re-open Arthur Hill.

We reviewed the options presented at the AGM:



- A-D have been tried, and sadly failed.
- We discussed E and F, which both involve trying to buy the pool. For the following reasons, we decided we can't take these options forward:
 - Fusion turned us down, which is telling

- The prospect of future competition from Palmer Park is a big issue in making a viable prospect
- The costs and the risks seem too great
- Swimming seems to have declined in popularity
- Failure to get RBC support will make it really difficult to make a success of the venture
- **Action Chris** We need to open this up to the wider Working Group to confirm that the majority agree with this. Chris to e-mail group for confirmation by Friday 26 May.
 - The decision will be added to these minutes and posted onto the website.

UPDATE 4 June: E-mail discussions amongst the working group have not been conclusive. Peter is keen to explore option F in a strategy day. Any viable proposal can then be presented to the Working Group & CIC board as an alternative to that discussed below.

• We decided that further communication to the community (& CIC members) can wait until we have decided what we are going do next.

For the record: I noted as chair that I think we should all be very proud of what we have achieved. Whilst it is disappointing that we couldn't find a way of reopening Arthur Hill, we did try everything we could. We got a lot done in a very short amount of time, but there were too many things stacked against us.

- We discussed options G & H, particularly with reference to the approx £10k raised through crowd funding.
 - We noted that some members of the working group may wish to reduce their commitment now that there isn't the pool to fight for.
 - However, we have established a useful group, and we hope there is enough energy to pursue our wider aims of promoting fitness and exercise (i.e. option G).
 - We agreed that it would be good to try and keep going until the new 'Palmer Park' pool is supposed to open.
 - We agreed with my proposal that the £10k would be better set up in some form of trust fund, which local schools (etc) can bid for. This would be a good to make sure monies do not get swallowed up into generic school budgets.
 - We did agree that the £10k (from the crowd funding) must be ring-fenced for schools rather than community activities.

- However, if we do have a trust fund, it would be possible to bid for money / sponsorship / donations to bolster this fund. This additional money could be used to fund wider community activity bids.
- If we do not have enough willing volunteers to make option G possible or
 if we fail to attract bids from schools we can always fallback to option H.
 In this case we will divide any remaining funds, between local schools, and
 start the process of folding the community interest company.
- In addition, Phil noted that the 'Friends of Arthur Hill' do not want to close either. If we keep going, maybe we can join forces. Phil has also started doing some East Reading community trails, which could become a part of our offer.
- **Action all:** to consider these ideas over the next month (until the next meeting) and discuss via e-mail.

• Agenda items for next meeting:

- To discuss what direction we are going to take forward.
- Based on this, to decide whether a 'strategy day' is appropriate, what are its aims, and to make arrangements to set it up.
- To consider plan / time-frame for informing members (+ directors) and the community of our change of direction.
